Some sections assume permission unless notified otherwise and others require your explicit permission.

There are six areas covered by this note:-

- 1. Local excursions for sport, HSIE, Care rewards etc.
- 2. Publishing of materials/photos/video.
- 3. Rock and Water program
- 4. The viewing of G and PG rated movies
- 5. Child Protection Program
- 6. SRE (Scripture) & SEE (Ethics)

We ask all parents and carers to read each section carefully, before signing, and remind them that they have the right to withdraw permission at any time. If, at any time, any event or service that has been announced is not deemed appropriate by parents or carers, they have the right to withdraw their children from them.

Whilst parents are permitted by law to take photographs or videos at school events, parents are advised that if this causes a concern for the safety or privacy of their own child, they may withdraw their child from the event. Parents should also be aware that they should not post any information/images of students other than their own on social media, without gaining explicit permission from each individual and their parent/carer first. Parents should also be aware of the risks involved in posting images of their own child on social media.

Please be advised that we take your child's privacy seriously and will only use first names (and occasionally last initial) when posting images on our website/app and other forms of media.

Please read and complete the sections on the back of this note and return to the school as soon as **possible.** Please note that the one note can be used for all the children in your family. If there are different conditions for individual children please use a separate note for each child. These are available at the school office.
